Survey Background

- Survey of 488 leaders and employees of nonprofit organizations operating in Mass.
 - The survey was fielded online January 5 – February 1, 2026.
 - The questionnaire was offered into six languages: English, Haitian Creole, Mandarin, Portuguese, Spanish, and Vietnamese.
- Survey links were distributed to nonprofits by The Massachusetts Nonprofit Network, The Boston Foundation, and other partner organizations.
- This project was sponsored by The Massachusetts Nonprofit Network and The Boston Foundation.

Survey demographics

- **Senior leaders:** Most hold senior leadership roles, including 48% serving as Executive Directors, Presidents, or CEOs, 31% as other senior leaders.
- **Total budgets:** 57% report annual budgets under \$2.5 million; 61% have 25 or fewer employees, including 41% with 10 employees or fewer.
- **Diverse respondents:** 73% identify as women, 15% as BIPOC, and 16% as LGBTQ+.
- **Diverse organizations:** 31% report their staff are majority BIPOC, 18% same of their senior leadership and board.
- **Federally funded:** 70% report their organizations receives some form of federal funding, either directly or indirectly.

Key Findings

- **Federal policy is hitting hard.** Immigration enforcement and cuts to federal grants, SNAP, health care and other safety net programs have created fear, stress, and uncertainty. Two-thirds of nonprofits report increased demand for their services, even as many immigrants are afraid to seek help.
- **Nonprofits are increasing advocacy and expanding services.** Organizations, especially larger ones, are increasing their activity in coalitions and government advocacy. Many have expanded services to fill policy gaps, particularly around food and SNAP support.
- **Conditions are worse from the national level down to individual organizations.** Most nonprofits view Massachusetts, the U.S., and populations served as worse off than a year ago. Nearly half report their own organizations are worse off.

Key Findings

- **Staff and organizational well-being are taking a hit.** Federal policy changes have heavily impacted staff well-being, especially in BIPOC-led organizations. More than two-thirds say the Trump administration has made it harder to carry out their work.
- **Finances under strain as funding is harder to find.** Most nonprofits report a weaker financial position than pre-2025 – and they expect that to continue in future years. They also report challenges seeking funding, especially from foundations and state government.
- **Operating support is the top need.** By far, operating support is the resource most desired, followed by capacity building and better policies to protect nonprofits.

Better / worse off than 1 year ago

- Nonprofits report worsening conditions across the board compared to 1 year ago, with the greatest deterioration seen nationally and among the populations their organizations serve.

Large majorities see the US, Massachusetts, and served populations as worse off

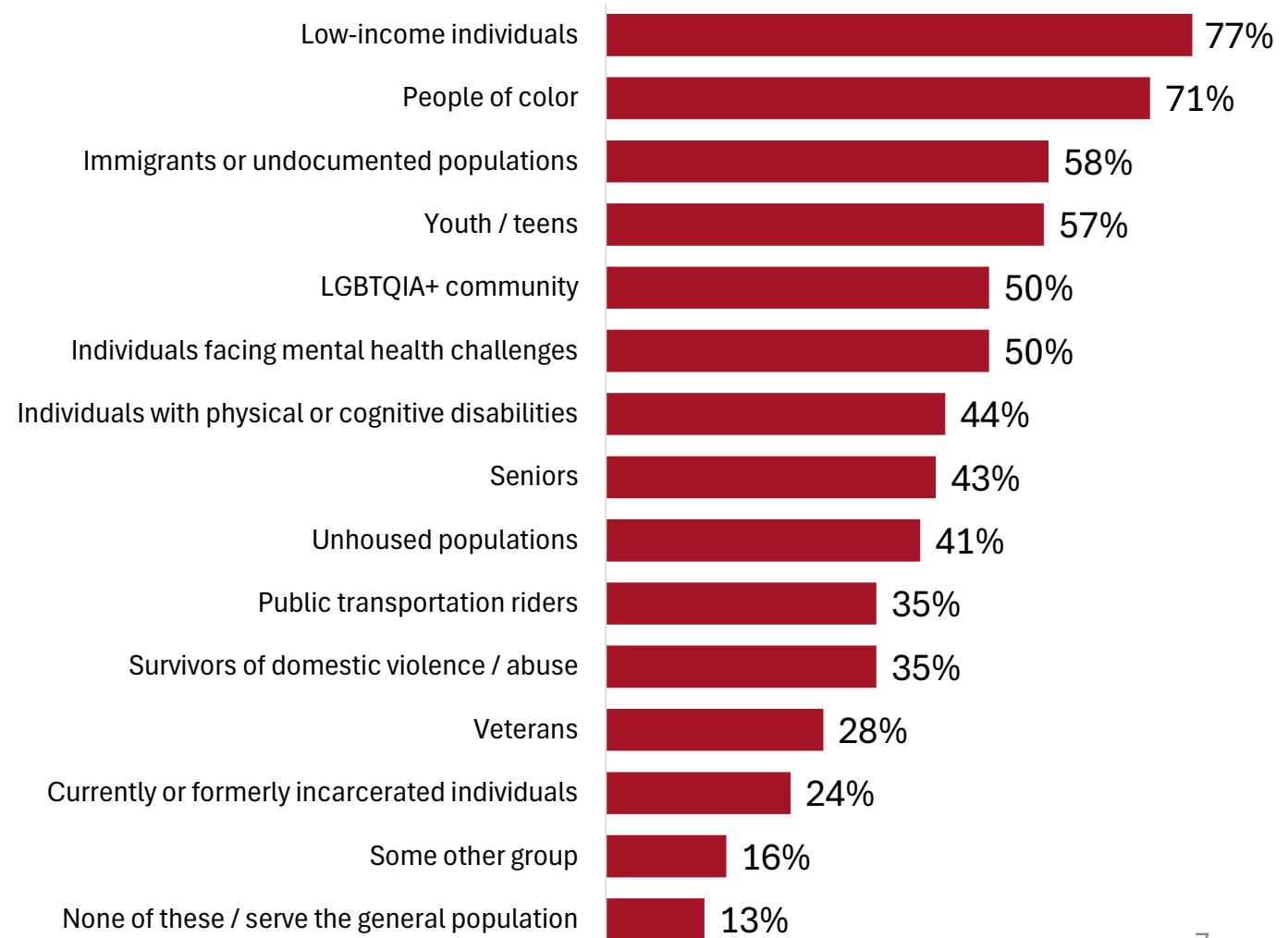
Populations served

- Nonprofits serve a wide range of populations, with low-income individuals and people of color the most frequent.
- Half or more also serve immigrants or undocumented populations, youth and teens, LGBTQIA+ communities, and individuals facing mental health challenges.

Challenges carrying out the mission

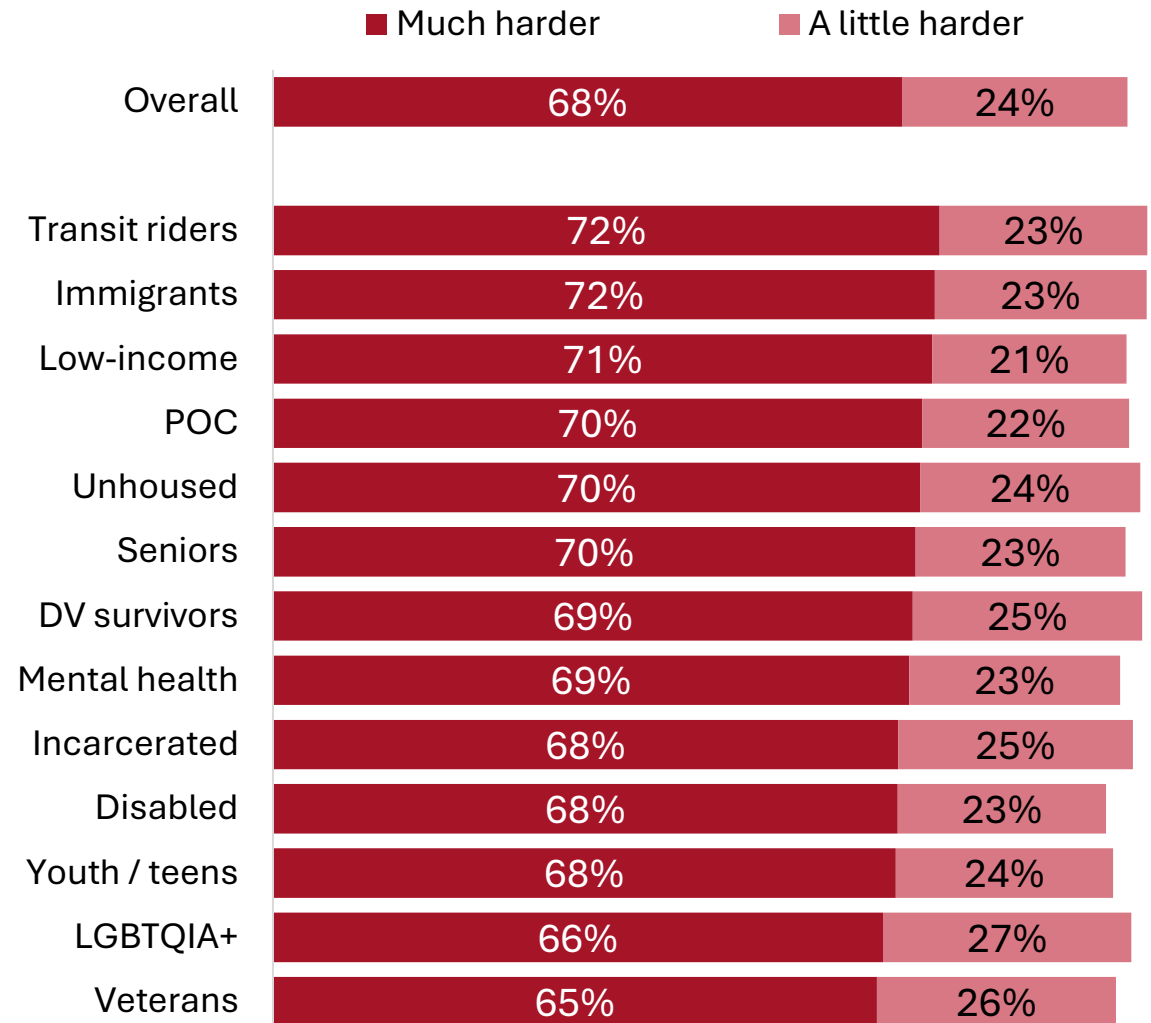
- Nearly all nonprofit leaders, serving a wide variety of populations, say the Trump administration has made it harder to do their work.

% who serve each pop who say Trump admin has made it ____ for org to do work



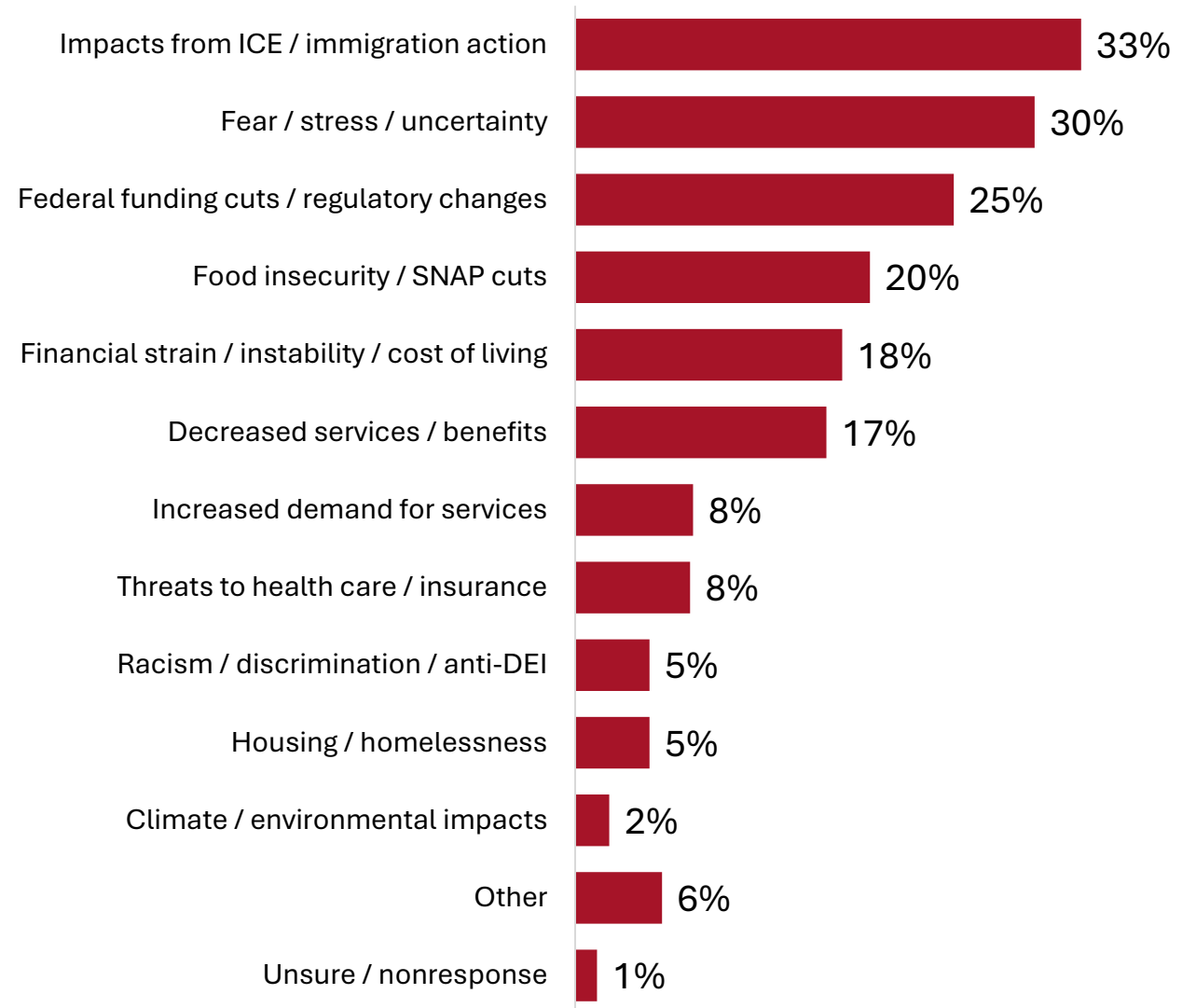
Negative effects on populations served

- Nonprofits report a wide range of negative effects due to federal policy over the past year.
- Impacts from immigration enforcement, along with rising fear, stress, and uncertainty, are most common.

Populations affected, in their words

Decreased income, worse mental health, fear of violence.

We are a diaper bank and clients are afraid to come to pickups because of ICE.

Less funding for their needs, confusing requirements, lack of support.

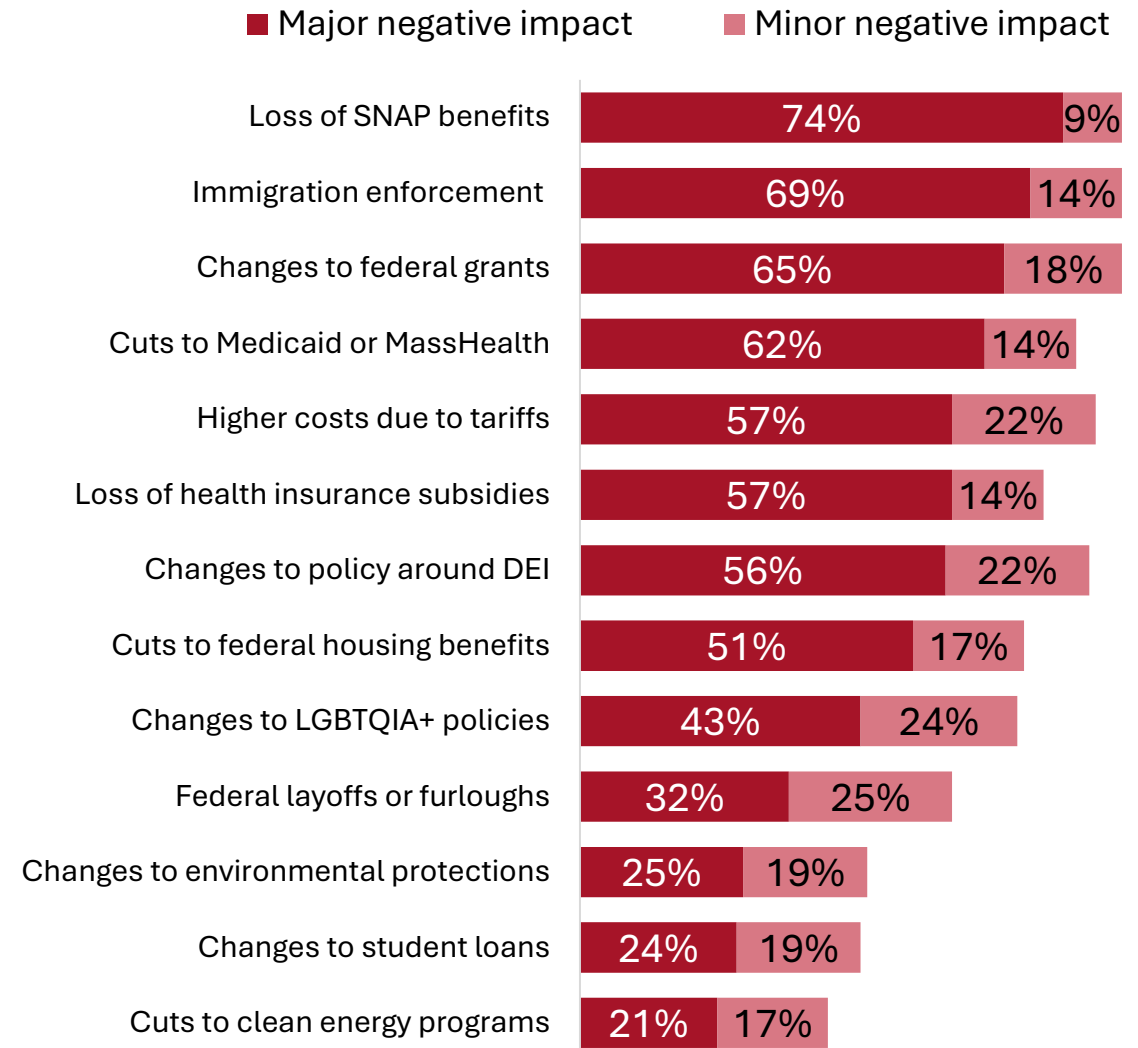
What has had the biggest impacts?

- Changes to SNAP, immigration policy, grants policies, and MassHealth have had the biggest impacts on populations served by nonprofits in Massachusetts.

Sweeping negative impacts under Trump policy changes

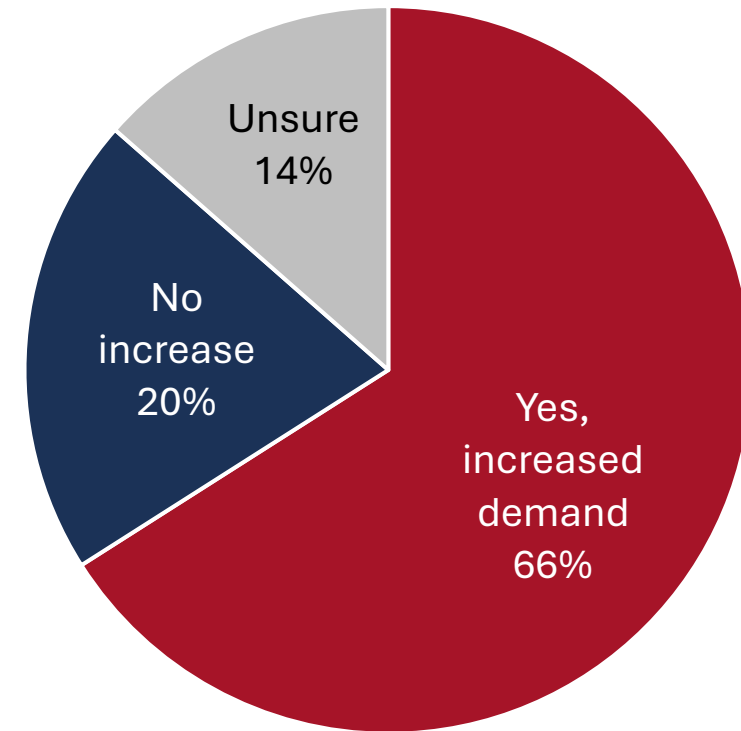
% who say each has had a ____ on the populations they serve



Increased demand for services / programs

- Organizations say there is now more demand for their services than 1 year ago.
- Organizations serving currently or formerly incarcerated individuals, people who are unhoused, domestic violence survivors, and veterans are particularly likely to report increased demand for services.

% who say they have / have not seen increased demand

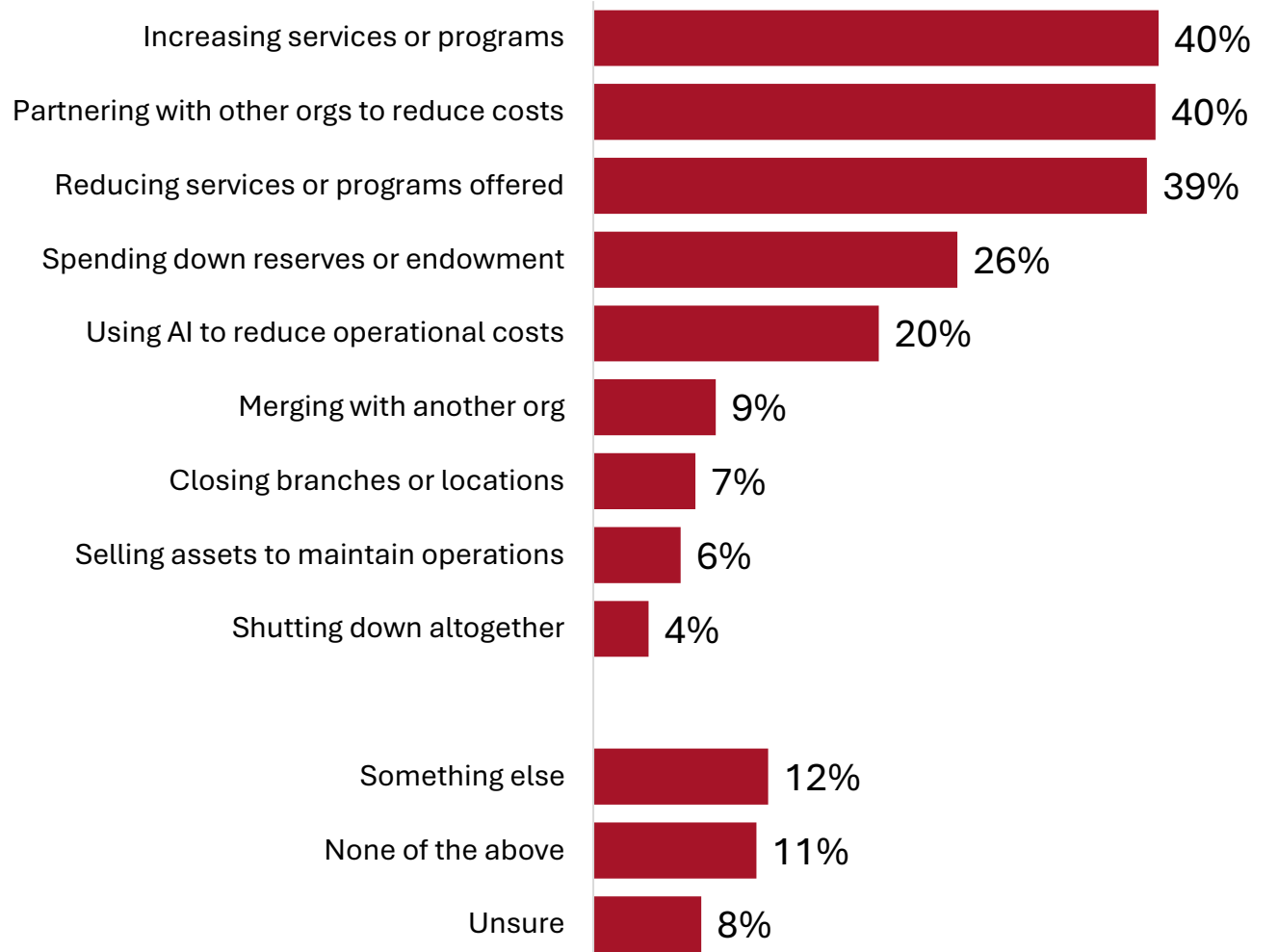


How organizations are responding

- Organizations are at a crossroads, with about an equal number looking at reducing programs as are expanding their services to meet demand.
- A similar percentage are looking into partnering with other orgs to trim costs.

% who say their org considered pursuing each in response to fed govt changes



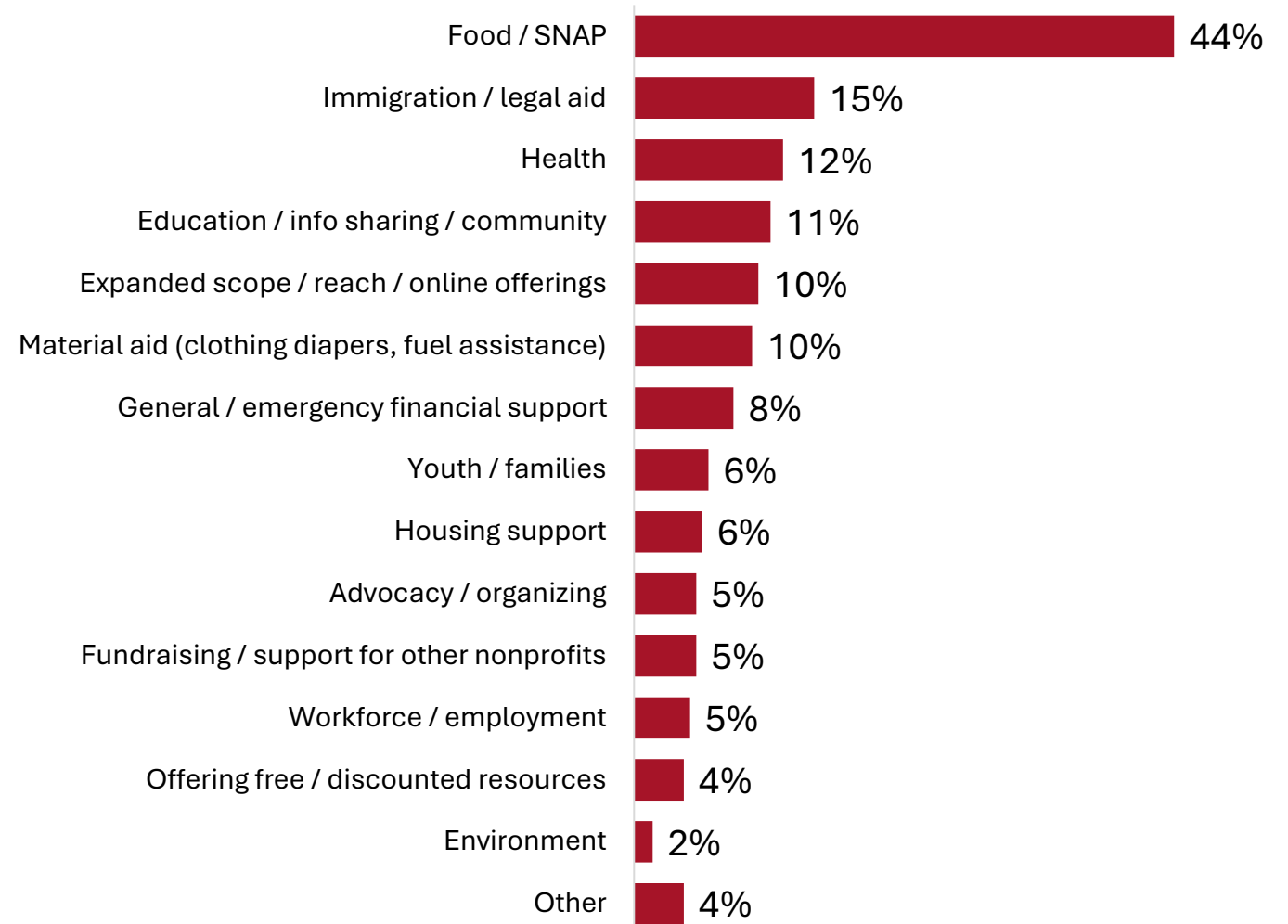

Expanded services to address demand

- Many (41%) nonprofits have expanded services in response to federal policy changes.
- The most widespread new service is food support to address SNAP benefit cuts.

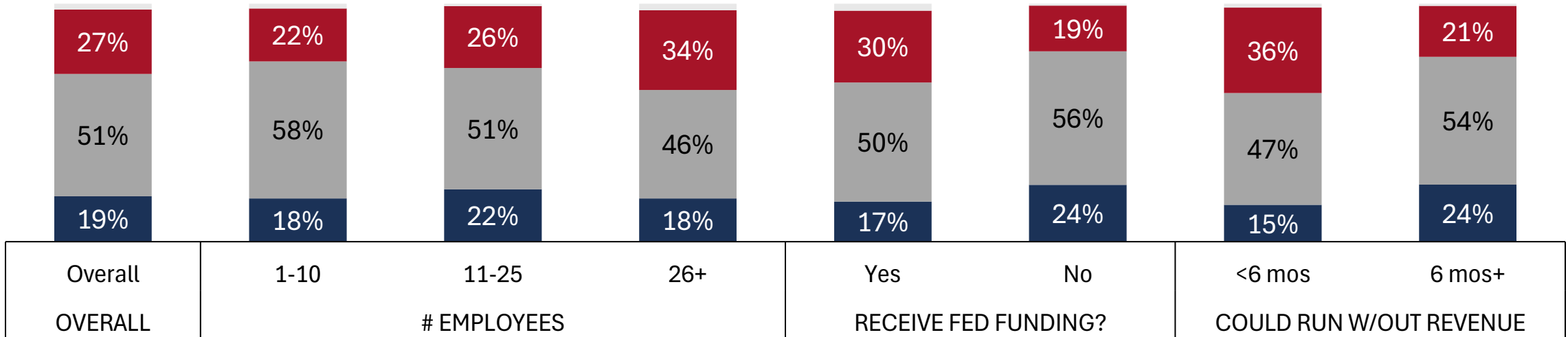
Changes in staffing

- Overall, 51% say their staffing has stayed steady, but 27% have cut jobs.
- Larger nonprofits, those receiving federal funding, and those with less financial running room are more likely to report their staffing levels have declined.

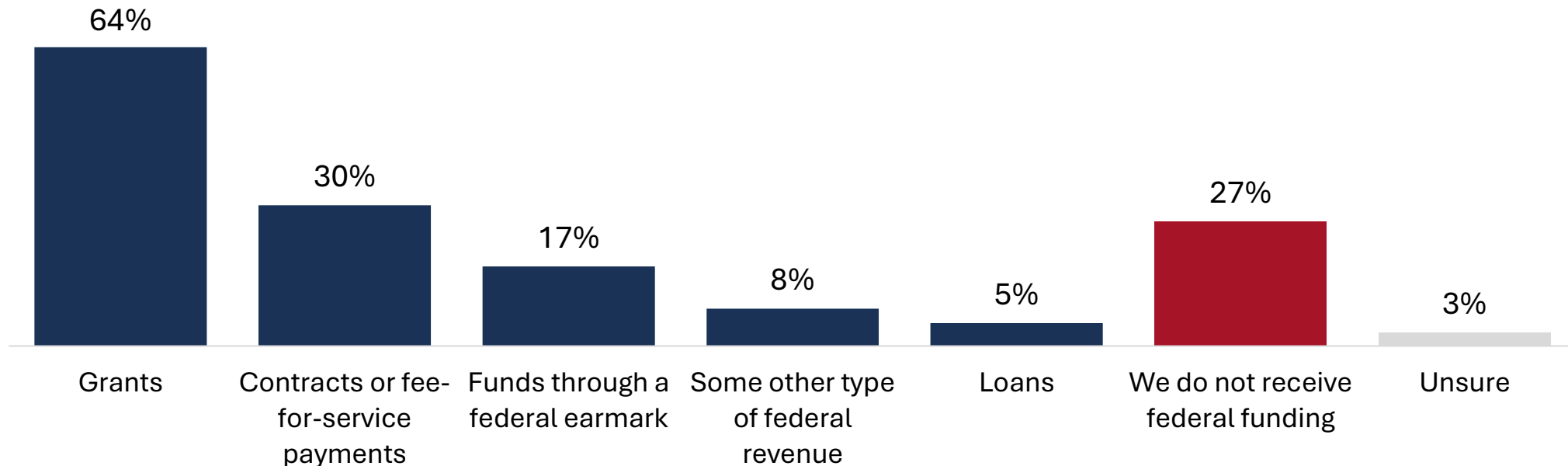

Receive federal funds of any kind

- Overall, 70% of nonprofits surveyed receive some form of federal funding, most commonly grants.

% who say their organization typically receives _____ revenue from the federal government

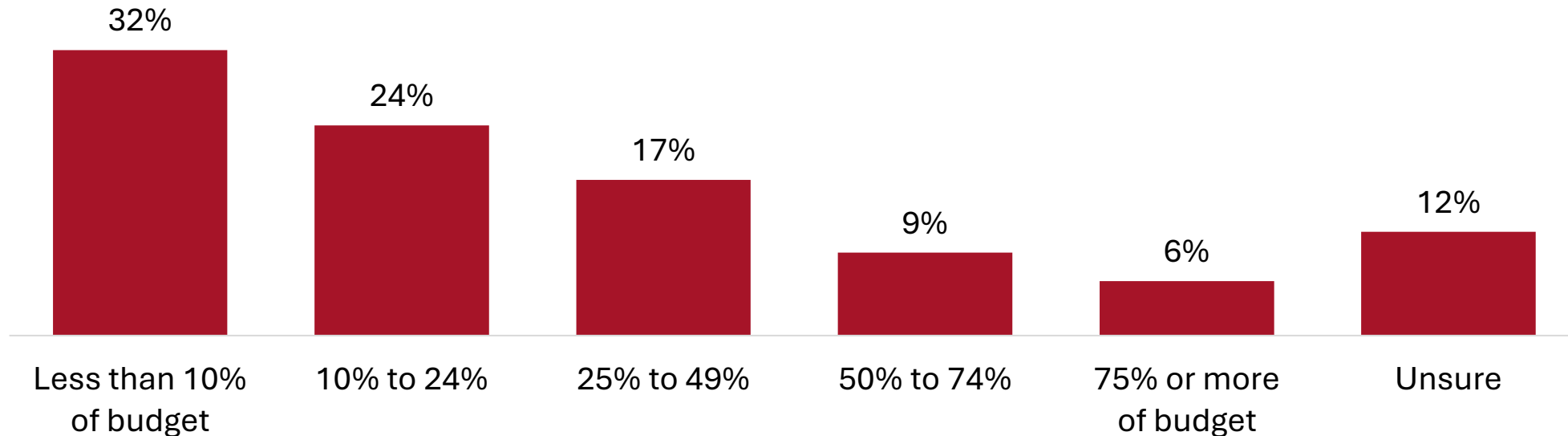


Federal funds in nonprofit budgets

- For most nonprofits, federal funds were less than 25% of their budget before the second Trump administration.

Most nonprofits had under 25% of revenue from federal funds before Trump's second term

Current and projected financial standing

- While not as bad as projected in the 2025 survey, nearly half of nonprofits have seen their finances weaken over the last year
- Looking ahead another year, 41% anticipate further weakening.

Financial health has weakened and nonprofits anticipate it will weaken more

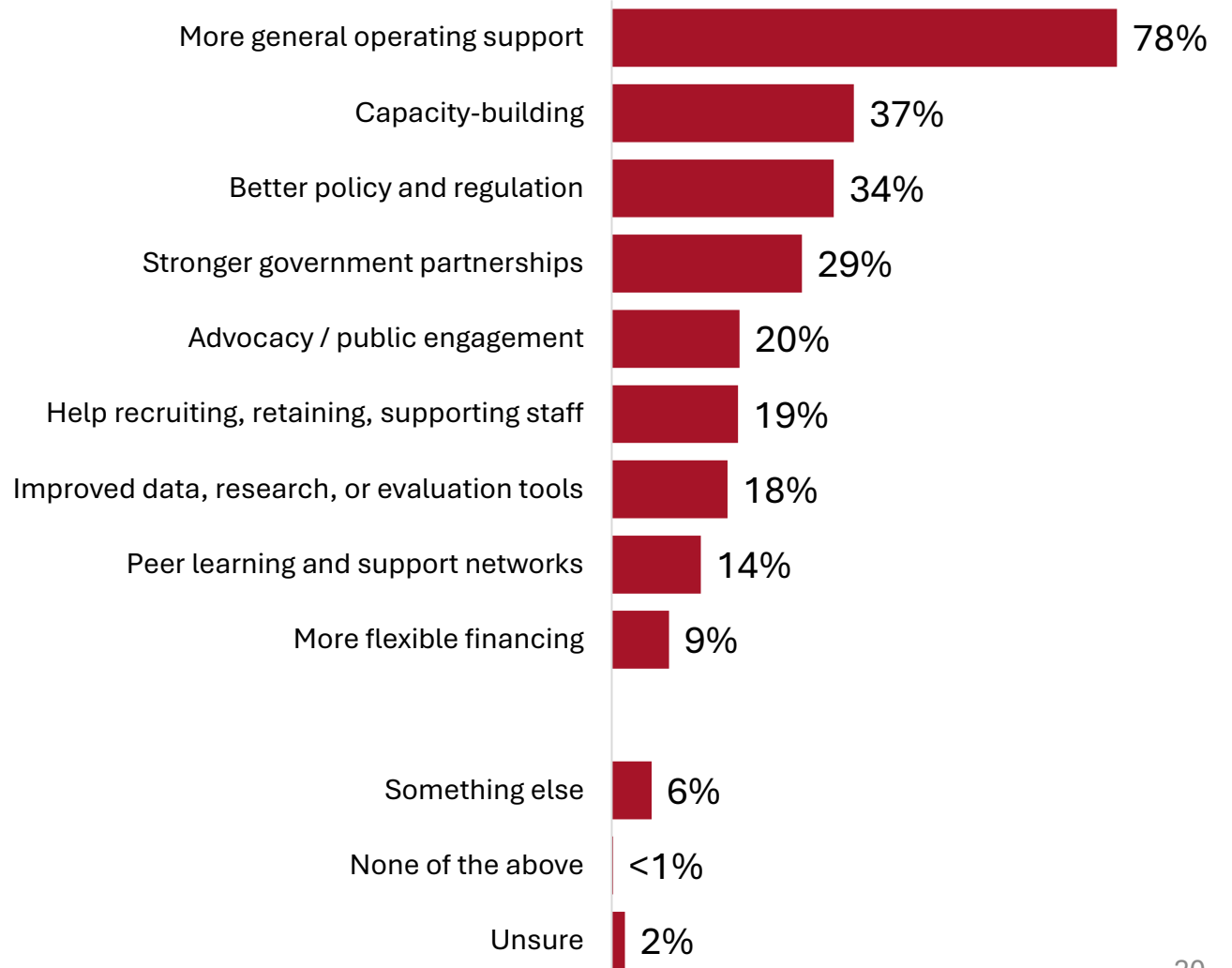
What nonprofits want most

- Operating support is by far the greatest need identified by nonprofit leaders.
- Capacity building is second, with smaller nonprofits more likely to seek this assistance.

% who say _____ resource would be most helpful for their org

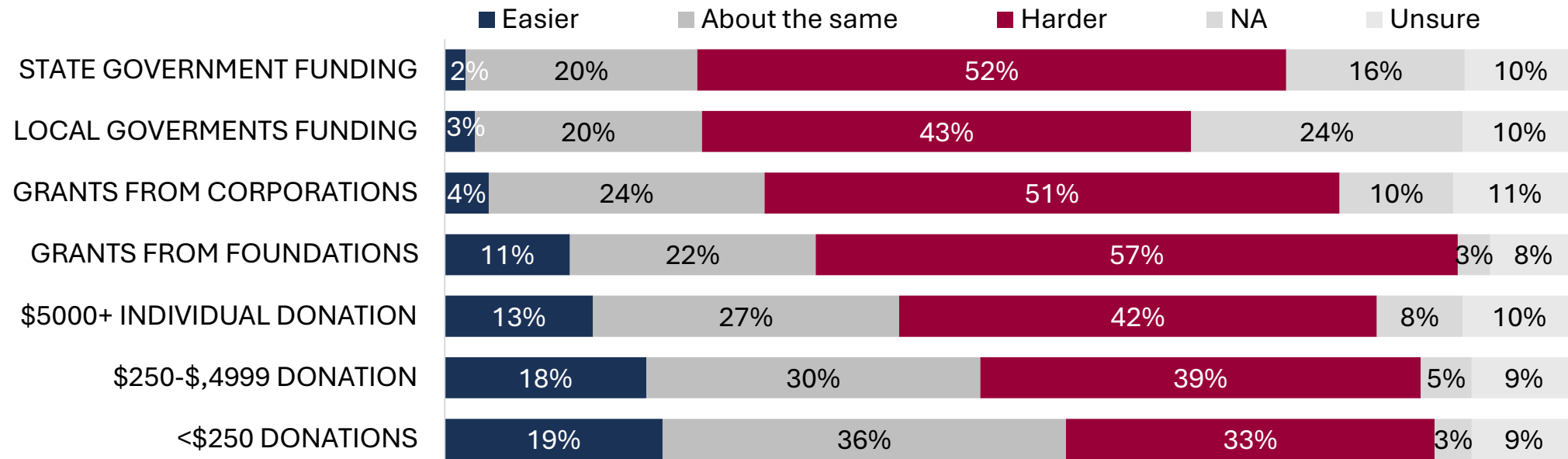


Fundraising landscape

- Obtaining funding has become more challenging compared to prior years, particularly state government funding and grants from corporations, and foundations.

More nonprofits say every category of funding has gotten harder to get compared to prior years

% who say each type of funding is _____ to get compared to prior years

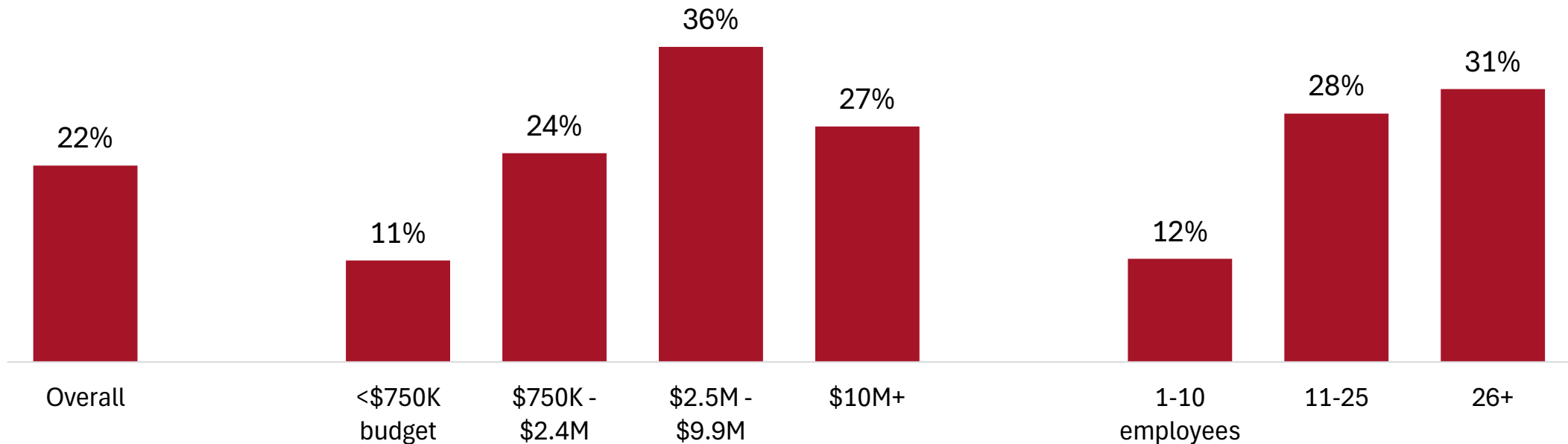


More nonprofits are adding security

- Many nonprofits, particularly larger ones, say they have added security over the last year.

Security has increased in the past year, particularly for larger organizations

Advocacy on the rise

- Many organizations are taking on new advocacy activities, particularly those with the largest budgets.

Nonprofits increase participation in policy advocacy, particularly larger organizations

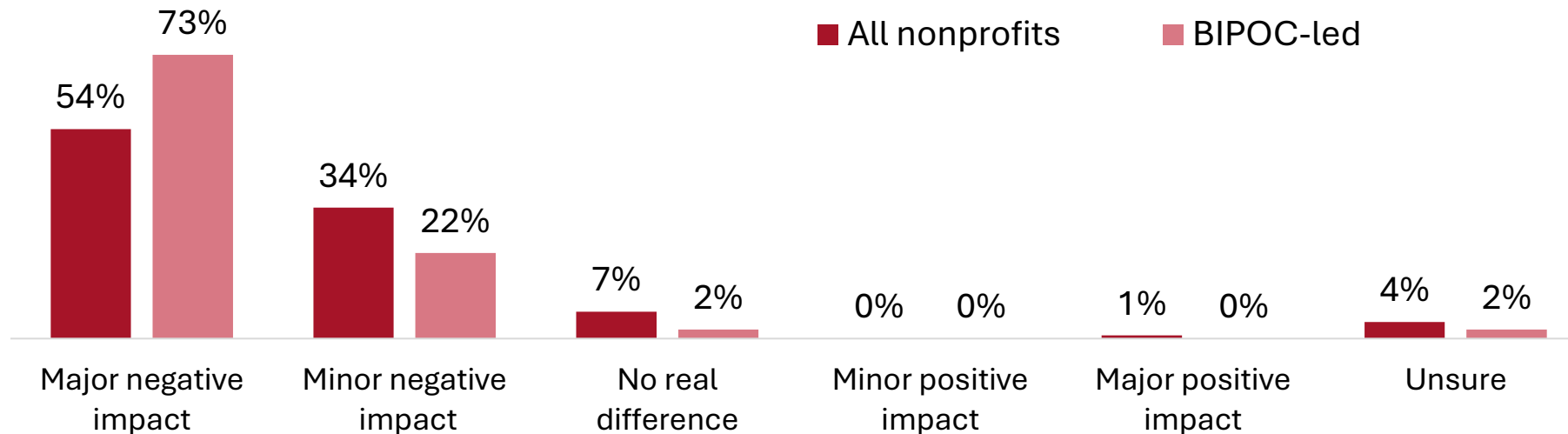

Impacts on nonprofit staff well-being

- Nonprofit leaders see negative impacts on their staff from federal actions; nearly no one reports a positive impact.
- BIPOC-led organizations feel particularly hard hit.

% who say federal actions since Jan 2025 have had a _____ impact on the well-being of org staff

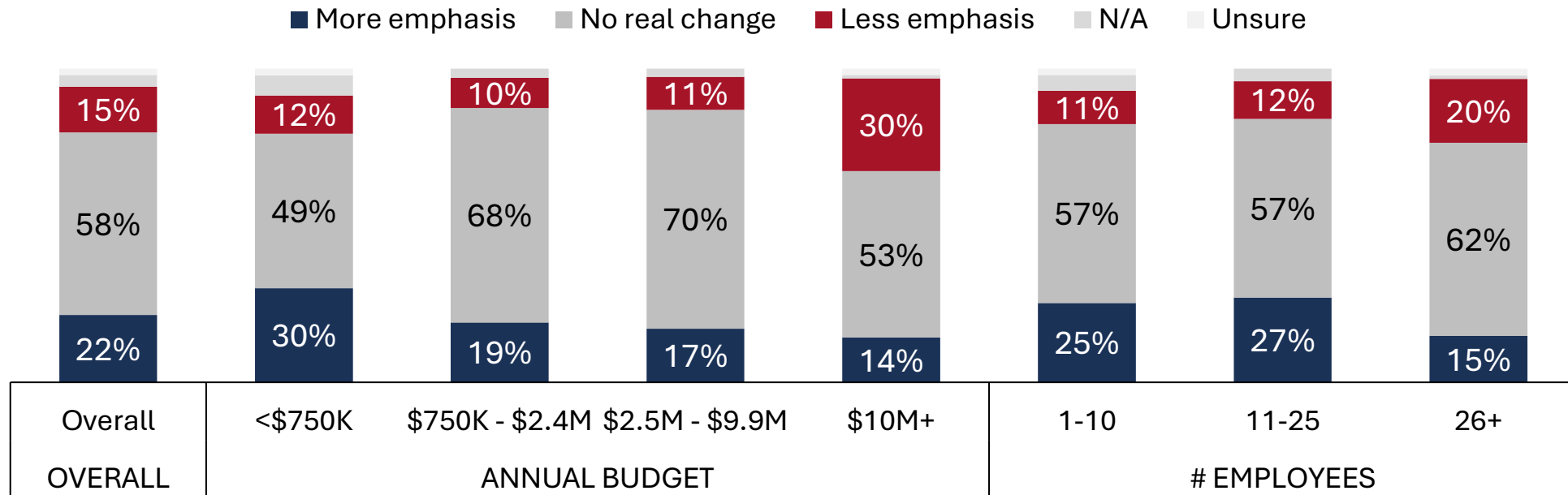


Changes to DEI emphasis

- Overall, most nonprofits report “no real change” regarding their emphasis on DEI. Smaller organizations are more likely to say they are leaning into DEI, while more larger orgs are pulling back.

Key metrics: forecast vs actual

- In 2025, nonprofit leaders were fairly accurate in forecasting how bad things would be in Massachusetts. Very large majorities say demand for services is higher, Mass is worse off, and it's now harder to carry out their mission.

Increased demand for services amidst a more challenging environment.	This has occurred and some nonprofits have expanded services to fill the gaps.
Potential loss of federal funding would hit vulnerable populations and nonprofit budgets.	Loss of federal funds happened and had the expected impacts.
Even nonprofits that did not receive federal funding worried about downstream effects as philanthropic resources shift and become more competitive.	More say applying for funding from all sources has gotten harder.
Nonprofits foresaw a need to boost own fundraising to compensate, even while anticipating a worse financial position a year from now.	Few nonprofits say any type of fundraising has gotten easier or that their fundraising is better.
Nonprofits saw an increased role for philanthropy as the federal government makes life harder for Massachusetts nonprofits.	Nonprofits are reporting more challenges seeking funding, including from foundations.
